Dear Applicant,

Thank you for your interest in wishing to join the Federation of British Historic Vehicle Clubs.

We are a voluntary organisation which exists to uphold the freedom to use historic vehicles on the road *without restriction* something that many other countries do not enjoy. We do this by representing the interests of owners of such vehicles to politicians, government bodies/officials, and legislators both in the UK and through the Fédération Internationale des Véhicules Anciens (FIVA) in Europe.

Member clubs are encouraged to the FBHVC logo on the publications, website and stationery. They can be downloaded from our Members Area on the website.

Subscription & Payment

The subscription is priced depending on the number of members you declare. For Clubs whose membership is 64 or more members, the cost is 47p per member (capped at 10,000 members). For Clubs with 63 members or fewer the subscription is priced at a flat rate of £30.00. These prices are based per annum from 1 June to 31 May. Once again these rates have been held for 2024/25 – for the 5th consecutive year!

If joining part way through a year a *pro rata* payment will be required for each full calendar month remaining.

Our preferred method of payment is via Internet Banking. If choosing this method, please state your club name as a reference. Alternatively, we can accept credit/debit card payment over the telephone (01708 223111) or a cheque in the post.

Magazine

We send one paper copy of our quarterly magazine *Historic* to your nominated representative and link to the electronic version will sent to all nominated contacts via email at no additional charge. If you wish to receive more printed issues, you have a choice; we can send additional copies to the same mailing address for an additional annual cost as below:

- Up to 2 copies to the same mailing address for an additional £15 per annum
- Between 3 to 5 copies to the same mailing address for an additional £22 per annum
- Between 6 to 10 copies to the same mailing address for an additional £37 per annum.

Alternatively, we can send one copy to a second address at a cost of £10 per year, for each postal address listed.

Please indicate your requirements on the renewal form. We are unable to post outside of the UK.

We welcome Clubs to reproduce material from *Historic* in your own publications. The only stipulation is the text must be unchanged and that credit is given to the Federation.
